Low Carbon Business Evaluation, Thurrock Council

The Low Carbon Business programme aimed to increase the competitiveness of the South Essex economy through a series of co-ordinated interventions that sought to address high levels of CO² emissions. Our evaluation of this ERDF-supported project included a detailed review of performance against spend, output and result targets, the changing delivery context, consultations with delivery partners and wider stakeholders. It also included an impact assessment based on a web survey of project beneficiaries.

The evaluation showed the project had performed strongly against its objectives of increasing business' understanding of their environmental impact, reducing business carbon footprints, reducing waste of resources and creating new employment opportunities. It was used to help shape plans for future low carbon business support investment in the area under the 2014-20 ERDF programme.

Summative Assessment Design Advice: Investing in Greater Birmingham ERDF Project

Investing in Greater Birmingham aims to bring new inward investment into the city region through marketing and investor support activities. Marketing Birmingham wants to ensure their Summative Assessment captures and clearly communicates the project's net additional impact. They commissioned Regeneris to advise on the evaluation approach before they started to deliver the project.

We designed an evaluation framework that sets out how the Summative Assessment can capture various quantitative and qualitative impacts and attribute these to ERDF funded activities. The various data collection proformas and research tools that we created will help the delivery team capture essential monitoring information as they deliver the project and ensure the Summative Assessment is credible and robust.

Regeneris has been retained to advise Marketing Birmingham as it uses these research and analytical tools and we will be doing a Summative Assessment in 2019.

English 2014-20 ERDF Evaluation Scoping Study

DCLG wanted to design a high quality approach to monitoring and evaluating the entire English ERDF programme. They wanted to ensure that the programme level evaluation would provide robust and reliable evidence of the impact created by £2.8bn of investment in ERDF projects.
