ECONOMIC IMPACT ASSESSMENT

Michael managed and drafted the Socio-Economic chapter of an Environmental Statement for the proposed Neart na Gaoithe Offshore Windfarm in Scotland. He has previously worked on estimating the size of the Midland Energy Sector and the socio-economic impact of HS2 on the London Borough of Hillingdon. Much of his other work in evaluation and economic assessment has drawn from his knowledge of Input-Output modelling. Furthermore, Michael is experienced in reviewing literature that aims to better understand programme impacts. Most recently, working with Probono Economics, Michael is assessing the impacts of Walking with the Wounded, a charity which aims to support homeless veterans into employment.

ECONOMIC RESEARCH AND ANALYSIS

Building on from his academic background and work at the Bank of England, Michael is often called upon to manage the data side of projects, which encompasses collation, manipulation, and analysis, using of a range of statistical software.
